

Consent Contract

Review the following expectation. These expectations are non-negotiable. Read this form in its entirety, sign and return prior to the session.

For purposes of this contract and clarification _____ shall herein be referred to as the **Client** (submissive) is entering into the session with "Goddess Capri" herein referred to as **Goddess (NEVER Mistress)**. This contract acts as written consent to a BDSM/Fetish session, which may or may not include physical/impact play and torture or mental torture among other consensual BDSM activities.

ARRANGEMENTS

During professional Femdom/Fetish/Findom Sessions I practice, SSC. The **Client** will agree and accept any terms of punishment/reward **Goddess** decides to assign, within the constraints of SSC and within the negotiations of the scene. Punishments/Rewards are subject to certain rules designed to protect from intentional abuse or permanent bodily harm. Punishments/Rewards must not incur permanent bodily harm, or the following forms of abuse:

1. Drastic loss of circulation
2. Causing internal bleeding
3. Loss of consciousness^[SEP]
4. Withholding of any necessary materials, such as food, water, or sunlight for extended periods of time

Professional Relationship Boundaries: (initial next to each statement)

- **Goddess** is a professional and will be compensated* for time spent in any sessions with the **Client**.
- **Client** maintains to keep a professional relationship with **Goddess** including but not limited to contacting **Goddess**, outside of booking or conducting business.
- **The Client may ask for orgasmic release at the end of the session, however this request may or may not be granted.**

SAFETY

Safe Words:

Safe word #1 **Green**; meaning **everything is fine/ unexpectedly enjoyable (continue harder/faster/etc.)**

Safe word #2 **Yellow**; meaning **proceed slowly**

Safe word #3 **Red**; meaning **stop immediately**

Safe word #4 **Medical**; meaning **you need medical attention immediately**
